First, I would like to thank the Commission for all their hard work. The Redistricting Map is headed in the right direction. Residents on Zoom and In-Person liked the suggestion to draw new districts by using a blank map, and also liked keeping the Escondido historic District together.

Escondido City Redistricting: 1/12/22 Requests

Good evening Escondido Independent Redistricting Commission.

First off, thank you for addressing the audio issues as best as you could. La Coalición de Semillas Malas Unidas en Escondido is comprised of Queer BIPOC/Latinx leaders, their networks, and allies. We are current Escondido residents, displaced North County residents, and our extended networks. As of the 2020 Census data, with consideration to undercounting, Latinx make up about 52 percent of Escondido's population, yet only see themselves reflected in one majority-minority district.

We make the following logistical requests for the Commission to: post more noticeable street signs to find the following In-Person meetings, make 2020 Census data accessible on the public website, create multilingual tutorials on "How To" fill-out the Community of Interest forms, post the public's comments and letters on the webpage, and implement heavy outreach in community spaces largely congregated by BIPOC (such as public schools and churches.)

Based on the last mapping visualization from Monday, January 10th, 2022, we request:

1. Moving the borders of current District 3 more Central, South, and West. Losing District 3's current neighborhoods in the North and East. Expanding in further neighborhoods Central, South, and West (Parts of current District 4).

- Preserving "Esco Viejo" (Old Escondido) in the Central, South, West based on resident definitions.

2. Moving the borders of current District 1 Central, North, and East. Expanding further in neighborhoods Central/North (Current parts of District 2) and East/North (Current District

3. Keep as many of the interchangeable areas where our Houseless neighbors congregate together.

Our coalicion partners will give more specifics on their neighborhoods in the next few weeks creating these borders based on our COIs. Below you will find a list of current Escondido residents, displaced

After last meeting I sat down to draw a rough map of what I think may make District 3 on your visualization a majority/minority district. I believe this District should be named District 1 as it is largely made up of the old District 1.

Please see attached map.

The boundaries of this District would be El Norte to North, Citrus and Bear Valley to the East, Oak Hill, Ash, City boundaries and Idaho to the South and Broadway to the West.

I believe that this may help to keep this District a majority/minority district as Commissioner Case mentioned.
